A report from President Leah Barrett included the following:

- The U.S. Department of Education has approved the renewal of Northeast Community College's TRIO program. The program, funded by a \$1.3 million five-year grant, is designed to provide individualized support and assistance to students who may have faced challenges in completing their education.
- Northeast Community College began the Fall 2020 academic year with a two-day, all-college In-Service. Virtual sessions were held the week of August 10th.
- Students of Northeast Community College will have an opportunity to gain additional credits
 between the upcoming fall and spring semesters during a special session of optional classes.
 The Intersession, which will feature a diversity of classes, will run from November 30January 15, with a break for the holidays in late December and early January. Registration
 will begin in October.
- Northeast Community College launched a new mobile responsive and engaging website that will better serve the college, future students, and the communities across northeast and northcentral Nebraska.
- Security Bank of Laurel, Allen, Coleridge, Osmond and Hartington has thrown its support behind new agriculture facilities at Northeast Community College with a \$25,000 pledge.
- Northeast Community College business students walked away with national recognition during a competition against their peers from other two-year and four-year colleges and universities across the United States and Puerto Rico this summer. Six members of the College's Phi Beta Lambda (PBL) Team placed in several areas in the 2020 National PBL State Leadership Experience and Business Competition after showcasing skillsets they gained in college.
- Members of the graduating class of Northeast Community College's physical therapist assistant (PTA) program are now prepared to enter the profession. The thirteen students from the Class of 2020 participated in an appropriately socially distanced recognition ceremony on August 10, where they received their PTA pins before family, friends, faculty and staff.
- New Student Orientation, which is typically held on the Sunday prior to the first day of classes, has been redesigned this year to be offered in a virtual online environment through Canvas instead of as an on-campus event. All 862 new students (to date) have been registered for this free virtual experience.
- A final virtual New Student Family Forum session was held on August 5. Over 80 families
 attended this last session to learn more about the services offered to assist Northeast students.
 Northeast staff members were on hand to discuss topics such as Financial Aid, Academic
 Support, TRIO, Disability Services, Career Services, Student Health Nurse, Counseling,
 Student Activities, On-Campus Housing and more.
