1. PLEDGE OF ALLEGIANCE

- 2. The Northeast Community College Board of Governors met for the Official Budget Hearing regarding the 2022-2023 College budgets on Tuesday, September 27, 2022. Notice of the Budget Hearing and Budget Summary and Notice of Special Hearing to Set Final Tax Request Budget Hearing was published in the *Norfolk Daily News* on Wednesday, September 21, 2022. Chairperson Robinson declared the Budget Hearing Public convened at 5:03 p.m., in Suites F & G of the Lifelong learning Center, located on the campus of Northeast Community College.
- 3. 2022-2023 budget, levy, and budget lid information for Northeast Community College, along with factors affecting operational funding and expenditures, was provided by Scott Gray, Vice President, Administrative Services.

2022-2023 proposed budget is as follows: General Operating Budget, \$53,756,812; Building Improvement Budget, \$17,720,211 for a Total Tax Supported Budget of \$71,477,023; Self-Supporting Funds Budget, \$32,219,008; for a Total of All Budgets \$103,696,031.

- 4. At 5:32 p.m., there being no further discussion on the proposed budgets, Chairperson Robinson declared the Budget Hearing adjourned.
- 5. Chairperson Robinson convened the Special Hearing at 5:32 p.m.
- 6. Mr. Gray presented information on setting of the Final Tax Request for 2022. The proposed 2022 property tax request for all funds is 0.092500 cents, down slightly from the 2021 property tax rate of 9.09400, with a Final Tax Request of \$32,265,093.37.
- 7. At 5:35 p.m., there being no further discussion on the Final Tax Request for 2022, Chairperson Robinson declared the Special Hearing adjourned.
- 8. The Northeast Community College Board of Governors met for its regular session Board Meeting on Tuesday, September 27, 2022 in Suites F & G of the Lifelong Learning Center, located on the campus of Northeast Community College. Chairperson Robinson convened the Regular Meeting at 5:35 p.m.
