Chairperson Robinson noted that a copy of the Nebraska Open Meetings Act is posted on the table at the back of the meeting room, along with a copy of the November 10th Board of Governors Meeting agenda and all printable supporting documents.

4. BOARD EDUCATION AND INFORMATION

4.1 Development/External Relations Report

4.1.1 NCCA Report

NCCA Annual Meeting that was held in Grand Island on November 6-7 provided a great opportunity to network with trustees from other Nebraska community colleges.

NCCA Legislative Day is scheduled for February 22, 2023. More information will be forthcoming.

This is the 50th anniversary of the community college system in Nebraska. In April, there will be a display in the State Capitol as well as more public awareness about community colleges.

Nicole Sedlacek referenced a handout, *What are the Key Attributes of a High-Performance Board*, received at the NCCA Annual Meeting and available in today's Teams site. She stated that the board governance process has helped the Northeast board to become a high performing board and should continually strive to become even better.

4.1.2 ACCT Report

The ACCT Leadership Congress was held in New York, October 24-29, 2022 and attended by board members Steve Anderson and Pat Wojcik. Northeast faculty member, Brian Anderson was in attendance and received the ACCT Western Region Faculty Award. Phi Theta Kappa (PTK) advisor, Andrea Suhr, accompanied Physical Therapist Assistant student, Kaitlyn Pongratz to the Leadership Congress as Kaitlyn received the PTK New Century Workforce Pathway Scholar award.

ACCT Leadership Congress is a great educational opportunity for board members to advance themselves. Steve Anderson was re-elected to another three-year term on the ACCT Board of Trustees.

Sessions during the Congress included information from the Higher Learning Commission (HLC) regarding the board's role in the accreditation process and the significance of board preparation. A session regarding foster care and how children fall through the system. Todd Holcomb, president of Hawkeye Community College, spoke about what their institution does for foster children and accessing state funds that are available for foster students. Mr. Anderson requested that Tracy Kruse speak to this topic at a future board meeting.

4.1.3 Foundation Board of Directors Report

During the October Foundation Board of Director's Meeting, Jill Heemstra, ag program director; Dr. Trentee Bush, horticulture/agriculture instructor; and Courtney Nelson, precision ag trainer, gave presentations on urban and precision agriculture activities that are happening.

Discussion was also held on funding gaps and identifying what can be done through the Foundation to assist students as funding gaps are increasing.

Lori Olson, Dana F Cole, attended the Foundation meeting to present and Foundation's Audited Financial Statement as of June 30, 2022 and 2021. The Foundation received an unmodified opinion.

4.1.4 <u>Higher Learning Commission (HLC) update: What to Expect and Criterion 1</u>
As Northeast Community College prepares for its comprehensive accreditation visit in October 2023, information will be provided during the next several board meetings to aid in preparing board members for the visit.

In 2014, Northeast Community College moved to the Open Pathway Accreditation Cycle, a 10-year cycle with the HLC. The 10-year cycle includes preparing the Assurance Filing in years 1-3; Assurance Review in Year 4; preparation of Assurance Filing for comprehensive visit and submission of the Quality Initiative (QI) proposal in years 5-7; submission of the QI Report and continue preparing Assurance Filing in years 7-9; and the comprehensive evaluation for reaffirmation in year 10.

Criterion 1: Mission - The institution's mission is clear and articulated publicly; it guides the institution's operations.

Northeast mission was developed in 2015 while creating the Vision 2020 Strategic Plan. enVISION Strategic Plan was launched in May 2021 to include new strategic priorities, value statements, and vision. The mission can be found in major publications, on the website, and in Northeast facilities. It is operationalized through academic programs and a wide array of support services. The institution's mission demonstrates commitment to the public good through student organizations that promote service activities through special projects. A volunteerism procedure was adopted to allow employees to participate in non-profit activities. The Board of Governors plays a key role in ensuring that the College focuses on its educational responsibilities.

Northeast Community College engages with external constituencies and communities through partnerships with K-12 schools (Fridays@Northeast, Pathways-2-Tomorrow, Early College); post-secondary institutions (Nebraska Transfer Initiative, Articulation Agreements, UNMC-Pathway from practical through doctoral nursing); and employers (Job Training and Safety Program, St. Francis Memorial Hospital, Tyson).

Northeast's nondiscrimination and harassment procedures, the work of the Engagement Team, administration of the PACE Climate Surveys, and Shared Governance and other feedback models are examples of how the institution demonstrates inclusive, equitable treatment and fosters a climate of respect.

Examples of how Northeast provides opportunities for civic engagement in a diverse, multicultural society and globally connected world include student clubs that support and educate on diversity and equity, study abroad opportunities, international student enrollment, being recognized as a Military Friendly School, and adult education programming for preparing for citizenship testing; English language instruction; instruction in basic reading, writing, and math; and preparation for a high school diploma.

4.2 Student Services Report

4.2.1 Financial Aid dashboards

During last month's initial review of tuition and fees comparative data inquiry was made with regard to issues that may prevent a student from attending Northeast. Stacy Dieckman, Director of Financial Aid, reported that through the work of the data analytics team, dashboards are now available that enable staff to review the analysis of applicants who did not enroll at Northeast. That information can be broken down to further reveal specific reasons that could deter a student from registering, e.g., childcare expenses, family unable to pay, etc., and enabling staff to identify opportunities that we can focus on to make decisions based on the data.

Inquiry was made to the possibility of providing low or no-cost childcare to students with children. For many years, Northeast operated a childcare facility. As is common with campus childcare, the program had been operating in the deficit, causing it to close. Early Childhood Education instructor, Lisa Guenther has been involved in discussions across the state. There are creative things being discussed and possible alternative ways of funding to make it sustainable. Northeast will remain involved in these discussions.

4.2.2 Rural Guided Pathways update

Northeast Community College is among 15 other institutions that were chosen through a competitive application process for the National Center for Inquiry and Improvement's (NCII) Rural Guided Pathways Project. Selected colleges

demonstrated the internal culture and positive external partnerships necessary to implement Guided Pathways.

In June, Northeast attended the first Rural Guided Pathways Institute that was held in Minneapolis, MN. Six community partners (representatives from Northeast Nebraska Growing Together, Wayne State College, South Sioux City Schools, Tyson Foods, Pathways to Tomorrow (P2T), and the Peter Kiewit Foundation) joined in the work to create better student experiences and increase the economic and social mobility of the 20-county region.

In October, the second Rural Guided Pathways Institute was held in Cheyenne, WY, focusing on reconsidering and redesigning the internal program mix. A good representation of Northeast faculty and deans attended along with Dr. Barrett and Amanda Nipp.

The third Institute will be held in Birmingham, AL and will focus on building upon the conversations of our programs and meeting community needs. Discussion is in progress with regard to attendance.

Sessions are facilitated by the Community College Research Center, Ascendium, and NCII.

4.2.3 Dual enrollment discussions

Allocation was received from the Appropriations Committee to support dual enrollment. Over the next several weeks, meetings will be held with the area high schools to advise them of how Northeast is planning to move to free dual credit enrollment beginning in Fall 2023. Free dual credit enrollment is building the college going culture. It enables high school students to explore opportunities prior to making a financial commitment. Free dual credit enrollment is also an initiative to support Northeast's role and mission. It fulfills our mission to our taxpaying constituents in providing opportunities for students to find ways to support our rural vitality. Board members were supportive of moving to the free dual credit enrollment. A full proposal will be provided in January 2023.

4.3 Administrative Services Report

4.3.1 Northeast Community College Financial Audit Report

Kerry Gustafsson, Dana F. Cole & Co., reviewed the Northeast Community College Area Financial Statements for June 30, 2022 and 2021, reporting an unmodified opinion, the highest-level assurance that can be given. She advised that no findings, no material weaknesses in internal controls, and no significant deficiencies were identified. Excellent cooperation and courtesy were received from management and staff.

4.3.2 Monthly Financial Report and Paid Bills

Brief review of the Monthly Financial Statement. Increases on the balance sheet are a result of receipt of a state aid installment. Funds were transferred into the Restricted Plant Fund for the purpose of paying some of the construction projects currently in progress.

Bills of significance within the paid bills report include payment to Ellucian as we begin the Cloud software subscription, M&B Quality Concrete for concrete repair on campus, and Huff Construction for renovations in the Lifelong Learning Center.

4.3.3 2023-2024 tuition, fees, housing, and meal plan rates

Little additional comparative data has been received from peer institutions in the past 30 days. Historically we have reviewed comparative data of local and regional institutions. Future comparisons will include data from our peer group as established by the Coordinating Commission for Postsecondary Education (CCPE).

Because the Northeast tuition and fees is currently higher than other community colleges in the state, and because unmet need in paying for tuition and fees still exists, it is recommended that there be no increase in tuition and fees rates for 2022-2023. The average housing and meal plan rates for the 2023-2024 will be maintained at \$4,570 per semester.
