#### 5. BOARD EDUCATION AND INFORMATION

- 5.1 Administrative Services Report
  - 5.1.1 Monthly Financial Report and Paid Bills

Brief review was provided to the Monthly Financial Statement. Items of note within the paid bills report included payment to Lang Diesel for a new Kubota that will be utilized by the Grounds department, payment to JH Hespe for Simon Hall updates, and to Huff Construction for renovations in the Lifelong Learning Center.

- 5.2 Development/External Relations Report
  - 5.2.2 <u>President's Update</u>

Legislative update:

- Nebraska is the only state that has no match for Perkins (CTE) funding. During the upcoming legislative session, Nebraska's community colleges will request a CTE funding increase of \$8,450,000/year.
- Nebraska has not expended all of its American Rescue Plan Act (ARPA) funds. Community colleges have drafted an additional ARPA funding request.
- Nebraska's community college's will not be requesting an increase in the levy authority, rather, they will request flexibility between the general and capital levy.

- A request will also be submitted for an appropriation's increase of 3.5% for the general fund and 1% for dual enrollment.
- Part of community college's purpose is to make education available to everyone and to provide a setting where every human has an opportunity to learn. Funding restrictions to support Diversity Equity and Inclusion (DEI) efforts will also be a part of the upcoming legislative session.

Discussion included how Northeast can be assured that faculty members allow multiple views to be brought to the table and that instructors remain neutral in their teaching. Dr. Barrett confirmed that processes are in place and can be utilized if a student feels that their view is not being heard.

• U.S. Senator, Deb Fischer, recently participated in an Agriculture, Nutrition, and Forestry Committee hearing entitled, "Farm Bill 2023: Research Programs." Senator Fischer's remarks during the hearing included how community colleges are playing an important and increasingly growing role in agriculture education and workforce training. As she concluded her remarks, Senator Fischer stated that she would like to host Chavonda Jacobs-Young, undersecretary for research, education, and economics at the U.S. Department of Agriculture, at the University of Nebraska and Northeast Community College in Norfolk to see "the really fabulous things they're doing there with precision agriculture. It is a very exciting time and it's a growing program for them Northeast that reaches out into rural areas of the state and the students that they're able to connect with and in keep agriculture strong."

# Professional Development and Networking:

- Dr. Barrett has made presentations to the LEAD Fellows at Wayne State College; Keya Paha, Brown, Rock (KBR) Leadership Program in Bassett; and to Leadership Nebraska on the Norfolk campus. Dr. Barrett also served as the keynote speaker to Leadership Nebraska and the AgCeptional Women's Leadership Conference that was held in November.
- Senator Robert Dover was hosted on the Norfolk campus; he will be on campus again next week.
- Northeast co-hosted the Norfolk Chamber's November Business After Hours.
- Attended the SkillsUSA recognition at the State Capitol Rotunda in Lincoln.
   College updates:
- Dr. Charlene Widener assumes the position of Vice President, Educational Services, effective February 1, 2023.
- A draft of the Higher Learning Commission Assurance Argument will be ready by the end of the term.
- Work continues on the compensation study.
- Fundraising activities are underway to support the Innovation Studio and South Sioux City facilities.

## College engagement opportunities:

- This fall, President Barrett met with the leadership of the three employee associations.
- Work of the Negotiation's Team continues.

## 6. COMMITTEE REPORTS

- 6.1 Governance Committee
  - 6.1.1 Content Review
    - The Governance Committee conducted a content review of EL-04, <u>Planning</u>, with no revisions suggested.
  - 6.1.2 Policy content was reviewed on GP-10, <u>Board Code of Conduct</u>. The Governance Committee is suggesting no revisions.
  - 6.1.3 Minor revisions, including reducing the Ownership Linkage plan from four to two years is suggested. First reading consideration will occur later in today's meeting.
  - 6.1.4 Board of Governors Retreat will be held on March 16, 2023 in Norfolk.
  - 6.1.5 Historically, the process for filling Board of Governors officers was based on a rotation schedule with new members starting at the bottom and rotating up the list, enabling them to observe and learn. That process has since changed with the implementation of the new governance process. A discussion was held on if there was value in officers serving a one-year or a two-year term. The governance process has improved and the involvement of the chairperson with the president has increased. It was suggested that officers hold positions for a two-year term to provide continuity. It has taken a few months for everyone to fully grasp the new governance process and having this year's officers serve again in 2023 would help to keep the new governance process moving forward.

Although board policies are fluid, the above process does not fully follow the process outlined in GP-14, <u>Special Rules of Order</u>. The aforementioned policy will be reviewed by the Governance Committee in January, with any revisions being brought forth for consideration by the full board at that time.

6.1.6 Discussion ensued regarding committee chairpersons and membership being a two-year term. At the end of the two-year term, some members of each committee should remain on that respective committee and others rotate to another committee. This process would allow committee continuity as well as provide the opportunity for new members to learn from existing members and gain a full understanding of each of the committees.

Governance Committee membership for 2023 includes: Dirk Petersen, Chairperson and members Donovan Ellis, Carol Sibbel, Jeanne Reigle, and Pat Wojcik. Scott Gray will serve as liaison.

- 6.1.7 Ownership Linkage Committee membership for 2023 includes: Nicole Sedlacek, Chairperson, and members Del Ames, Steve Anderson, Terry Nelson, and Jeff Scherer. Leah Barrett and Diane Reikofski serve as liaisons.
- 6.1.8 Board appointments for 2023 were discussed and will be approved later at today's meeting.
- 6.1.9 Discussion was held regarding the NCCA Board of Directors representatives.

  Nicole Sedlacek would like to remain on the NCCA board, but Steve Anderson would like to step back to allow other board members the opportunity to learn

more at the state level. Northeast Community College is unique with regard to NCCA representatives as Northeast has the remainder of the board serve as alternates. Should an appointed NCCA board representative be unable to attend a meeting, any of the alternates could attend in their absence affording Northeast the ability to cast two votes at the NCCA Board of Directors meetings.

Decision regarding the NCCA Board of Directors representatives will be TABLED until the January 12, 2023 meeting to allow board members time to consider interest in serving.
