Chairperson Jeff Scherer convened the regular meeting to order at 10:07 a.m.

### PRESIDENT'S REPORT

5.1. Monitoring Report(s) (Presenters: Leah Barrett)

## EL-01, Treatment of Students

Northeast Community College assesses student satisfaction, vital for retention and graduation, using the Ruffalo-Noel-Levitz Student Satisfaction Inventory every four years, next in spring 2026. High scores in safety, diversity, individual concern, and service compared to Midwest peers reflect student satisfaction. Compliance with safety regulations involves regular reviews, communication systems, and mental health services. The College ensures harassment prevention, with accessible reporting, Title IX coordination, and frequent training. Annual Clery Act reporting and Title IX surveys confirm adherence to safety and discrimination standards.

Northeast Community College emphasizes student confidentiality, service efficiency, and process transparency. Policies ensure data privacy under FERPA, and the RNL-SSI scores reflect service excellence. Procedures prevent task redundancy. The student complaint process, tracked via Maxient, supports fairness with outlined appeal procedures. Student involvement in shared governance is mandated, with committees requiring student representatives. Administrative policies are accessible, detailing rights and expectations, with ongoing reviews ensuring compliance and effectiveness in serving student needs.

Board members commented on the completeness of the monitoring report, including sufficient evidence. The work of the Governance Committee has improved the monitoring reports.

The Board of Governors assessed the monitoring report, EL-01, <u>Treatment of Students</u>, and determined that there is evidence of compliance with a reasonable interpretation.

## EL-03, <u>Treatment of Employees</u>

The Monitoring Report on EL-03, <u>Treatment of Employees</u> aims to ensure a fair, respectful, safe, and organized workplace at Northeast Community College. Recent surveys, including the Engagement Survey and the Title IX Climate Survey, indicate that the institution surpassed benchmarks in employee perceptions of fairness, respect, and safety. Faculty rates are lower and continued meetings are being conducted with employees to address areas of concern, including departmental collaboration.

Faculty representatives present at the meeting indicated that they meet monthly with Dr. Barrett, Dr. Widener, and Mike Walkowiak and reported much greater transparency than in the past. Although not an easy task, they work hard to share the information they have garnered with other faculty that have not participated in the individual meetings.

Overall, survey results confirm a positive work environment, aligning well with policy standards. Regular surveys and policy reviews are key to maintaining these workplace standards. Employee performance reviews follow an appropriate review cycle.

The Board of Governors assessed the monitoring report, EL-03, <u>Treatment of Employees</u>, and determined that there is evidence of compliance with a reasonable interpretation.

## 5.2. President's monthly update (Presenters: Leah Barrett)

Dr. Barrett provided an update on federal activites, reviewed professional engagement opportunities she has been involved in during the past month, and provided an updated on 2025 legislative priorities. Commended Courtney

Wittstruck for the incredible work that she has done this year for community colleges related to dual enrollment and the nameplate capacity tax.

#### 6. BOARD EDUCATION AND INFORMATION

## 6.1. Educational Services Report

### 6.1.1. Program Review

The Heating, Ventilation, and Air Conditioning (HVAC) program has maintained solid enrollment over the past several years which can, in part, be attributed to the program's positive reputation.

Close relationships are maintained with local HVAC dealers and wholesalers and with national testing and certification organiztions. Northeast provides certification testing for both students and the community. The certifications confirm each student's understanding of the course materials, if they need additional training, and potential areas of retraining.

The program exceeds graduation and credit hours requirements in addition to boasting a 68% success rate. Industry continues to strongly support the HVAC program by hiring Northeast's students.

Data and charts within the Heating, Vehtilation, and Air Conditioning (HVAC) Program Comprehensive Program/Discipline Review document were reviewed, providing a basis for recommendation for board action.

At 12:11 p.m., Chairperson Scherer declared the meeting recessed for lunch. As part of the Ownership Linkage Committee activities, the Applied Technology Dean and Associate Dean, along with the HVAC instructors and students joined the Board of Governors and administration for lunch.

Del Ames reported the following:

- The Foundation budget for FY26 was reviewed and approved.
- The Weller Foundation scholarships were reviewed and approved. The majority of the new scholarship recipients are Northeast Community College students.
- The Foundation Board is currently seeking nominations. We continuously invite new representation and are currently seeking new members. The Foundation enjoys a long history of dedicated Board members who truly believe in the mission of the College and its work to support the success of its students and our region. If any Board member wants to share a potential nominee for the Foundation Board, please contact Tracy Kruse.
- There are four members whose terms end in 2025 and they have all agreed to extend their service to another term. Officers are elected for one-year terms at the annual meeting of the Foundation and normally will serve a minimum of two years, and a maximum of eight consecutive years. Roy Miller has served as Treasurer since 2017 and

- will step down on June 30th. Tracy and staff will work to find a replacement for Mr. Miller.
- The Scholarship Luncheon was held on April 16, 2025. The event was a
  great success and is always a wonderful opportunity for students,
  donors, and Board members to meet and discuss the student's
  educational goals and plans. This was the largest event to date with
  over 200 attendees.

## 8.3. Student Services Report

#### 8.3.1. Commencement Overview

## 8.3.2 SNAP E&T update

SNAP, the Supplemental Nutrition Assistance Program, provides food benefits to families and is managed by the USDA's Food and Nutrition Services. The SNAP E&T (Employment and Training) program helps SNAP recipients gain skills for sustainable employment. States, granted \$300 million annually, design SNAP E&T programs aligning with community college initiatives to boost student success. Community colleges serve as third-party providers, partner with state agencies, and receive reimbursements up to 50% for student services, reinvesting in support services. Monthly orientations, guides, and workshops are offered.

## Northeast's plans include:

- Begin with the GAP and Adult Education intake processes to include students who qualify for SNAP.
- Start small and design the program for scalability.
- Develop a "Next Step" program for adult learners across all areas to reduce SNAP stigma and expand access.
- Co-enroll students with SNAP to cover gaps from other programs.
- Consider becoming an Outreach Provider for more comprehensive services.

- Seek funding partners to support program expansion and growth.
- Northeast will submit their application by June 30<sup>th</sup> and begin participation on October 1, 2025.
