PRESIDENT'S REPORT

5.1. Monitoring Report(s) (Presenters: Leah Barrett)

Dr. Leah Barrett presented the monitoring report, E-00, <u>Global Ends</u>, highlighting the following key compliance evidence:

- 59% of graduates are locally employed; 91% are employed in Nebraska.
- Employer satisfaction rate is 98.1%.
- Expenses have not exceeded budget for the past five years.
- All credit students are now enrolled in defined fields of study.
- Graduation rates exceed peer groups by 16% and the national average by 22%.
- Northeast has 39 articulation agreements with other institutions of higher education. Each agreement is different; the agreement with UNL includes class-to-class transfer.
- Dual credit growth is strong and confident that 2026 numbers will be on upward trajectory.
- In eight of the past nine years, more than 50% of the students served are seeking workforce development and we see significant opportunity to grow as we dedicate resources to support adults returning to college and the introduction of Workforce Pell.
- The cost to attend Northeast Community College is less than our fouryear partners and is less than the Nebraska Coordinating Commission for Postsecondary Education (CCPE) peer-group median.
- Students have access to a traditional college experience that includes campus living and a comprehensive program of student activities.

Opportunities for improvement include:

- For 2026, we need to learn more about our transfer students.
 Approximately 225 of our completers transfer with more than half of those transferring to Wayne State College and the University of Nebraska system campuses of Lincoln, UNMC, Kearney, and Omaha. We want to dig deeper into this data and learn more about those students who transfer but do not complete a credential.
- Continue to grow dual enrollment
- Increase the enrollment of students who are seeking upskilling and reskilling.

The Board of Governors assessed the monitoring report, E-00, <u>Global Ends</u>, and determined that evidence supports compliance with a reasonable interpretation. Dr. Barrett provided a reminder that she will not be reporting on EL-00, <u>General Executive Constraint</u>, as it is only completed every other year.

Additionally, Dr. Barrett inquired if the Board of Governors has a desire to dig deeper into AACC's 'Resilient by Design: The Future of America's Community Colleges'; possibly as a future retreat topic. When thinking of everything that is going on in higher education, it might be good to dive into the document to assure that we are in tune with the influences of our educational system.

5.2. President's monthly update (Presenters: Leah Barrett)

Dr. Barrett provided praises to employees for the following:

- Submission of the FIPSE grant applications to access additional funds for the iHub. This is a statewide grant led by the Department of Labor.
- Aspen Prize application was led by Lindsay Spiegel and Jen Greve and submitted on Tuesday.
- Pack the Pantry efforts raised 900 pounds of food to support students.
- 9 to 5-The Musical, received rave reviews!
- 9th Grade Career Day will be hosted on Friday. Approximately 500 students will be on campus for this event.
- Ag Research presentations were judged by employees.
- Workforce Liaison positions have been filled. Their work will elevate
 workforce development throughout our service area. Three zones: zone
 one covers eight counties; zone two will serve 7.5 counties; and zone 3
 will serve five counties.

Unicameral and Federal updates:

2nd session of the 109th legislature will begin in January. Governor's agenda includes:

- Tax shifts to reduce property tax.
- Nameplate bills
- SNAP E&T changes
- Concern about state funding.

Federal landscape includes:

- AHEAD Workforce Pell. Richie Morrow from Nebraska will serve on this committee.
- Concern with rules around RISE Committee and annual loan limits

- Grants. Landscape is unique and interesting. There are dollars dedicated to rural healthcare. Nebraska Governor did submit approval that has not yet been made public. Hopeful that there are dollars for community colleges around rural healthcare.
- Government is funded only through the end of January 2026.

Recent activities/events that Dr. Barrett has participated in includes:

- Elevate Conference: Apprenticeships are in our future!
- NSWERS Strategic Planning. Meetings conducted across the state to collect data and perspectives. The work is powerful to us as an institution.
- Norfolk Childcare Collaborative advances. Northeast Community has made a commitment to this Collaborative. Space at the Presbyterian Church will be utilized. Currently in the zoning process to change to special use.

President welcomed guests over the past month:

- Leadership Nebraska. Dr. Barrett met with and presented to the group of 45.
- Nebraska LEAD program visited Northeast and their reunion is planned for January.
- Philanthropic foundations visit and explore partnerships. Toured residence halls. Brandon McLean and his staff do an amazing job at maintaining our facilities.
- Senator Ricketts and his staff visited Northeast. New Ag Liaison is from Madison. She was impressed to visit the Northeast campus.

Dr. Tee Bush provided a brief history of the Urban Ag project. and introduced student, Chrissy Clark.

Ms. Clark first spoke about her experience at Northeast, noting that it has been a phenomenal opportunity.

Ms. Clark presented a poster that she provided during the recent National Science Foundation (NSF) Advanced Technological Education (ATE) Conference.

Northeast's Urban Farm is 10 acres and includes nut and fruit trees, shrubs, raised beds, teaching garden, etc. Her experience to have so many varieties in a small space has been enlightening and also provides an opportunity to engage the community.

Shared research results on a small plot of land and explained remediation options to address contaminated soil.

6.1.2. C2A3 presentation

In the 10th year since the Community College Alliance for Agriculture Advancement (C2A3) began, Dr. Tracy Kruse reviewed the growth timeline from 2015 to today. The C2A3 network now includes 18 colleges in 16 states.

New opportunities in development include:

- Applied AI sensor kits and micro-credentials for five modules (crops, livestock, irrigation, controlled environment systems, ag equipment).
- Credential for Precision Ag Consultants embedded into credit programs and offered to incumbent workforce.
- Micro-credentials in Ag Cybersecurity.

Dr. Barrett reported that Dr. Kruse spoke yesterday during a webinar. The individual moderating the webinar acknowledged Dr. Kruse as the strongest community college development officer in the United States.

Items of note within the Monthly Financial Report included receipt of payment of student tuition for the Spring semester and reflected in the Revenue Fund. Government appropriations reflect and increase and attributed to a combination of state aid and Future Fund payments. The capital improvement column reflects a slight increase as property taxes continue to trickle in. The second installment will be received in May. Capital improvement expenses reflect payments made on the Maclay building for the completion of punch list items. Items of significance with the Paid Bills Report include payment to Applied Connective Technologies for providing internet in the dormitories, Blackbaud for alumni development software, Strata Decision Technology is an annual cost of licensing fee for budget software, Retail Services for student book buy back, and the Nebraska School Activities Association for an advertising package during high school championship events.
