Before Northeast Community College (Northeast) can issue a "Certificate of Eligibility for Nonimmigrant Student Status" (SEVIS Form S I-20) for a student visa to enter the United States, the applicant needs to have an official admission offer to enroll and must provide the following documentation:

- If the student, student's parents, spouse, relative, friend, etc. will fund the student's studies at Northeast, the student must provide an official bank statement showing the availability of the required amount in U.S. dollars and this Financial Affidavit form. Bank statements must be no older than three months and in English.
- If the student is sponsored by a government agency or a public or private institution, the agency must provide official certification that the appropriate costs will be covered.

I hereby unconditionally guarantee to support the above-mentioned student's educational costs and living expenses while they are enrolled at Northeast Community College. I understand that if the applicant is accepted at Northeast, they will be a full-time student and may not accept off-campus employment unless authorized by U.S. immigration services. I further understand that such authorization is difficult to obtain and should not be assumed.
